- 1) Please contact client a few days before to go over all details of the event, if there are any issues prior to event or on event day, you must contact client to do your best to remedy the issue. Or contact our company. DO NOT share too much info about your personal life, struggles, or non expertise in something or level or education on services or equipment being provided.
- 2) Appearance should be neat and clean, proper hygiene standards shall be met and vehicle should be in clean working order upon parking it at venue. Special pricing of props, show supplies, equipment etc.. is offered by our company should you need something prior to event date.
- 3) Entertainer agrees to all payment specifics above and anything over \$600 per person in a year will require a 10-99 tax form to be mailed to the entertainer.
- 4) Costumed character visits should be well thought out and vehicles and performers should park a block away from the house or venue. Singing telegrams should be discussed in advance with client or manager of venue or business. NO weapons, drugs or alcohol use AT ALL is permitted at events. The only exception to alcohol is working bars or nightclubs where a 1 drink maximum is allowed and must be permitted by the Owner or manager. If a client harasses any performer to the point the performer feels unsafe, a call or text must be made to our company. We will handle it from there and we may have police involved and entertainer may then leave at that time with FULL pay.
- 5) Tips are given in full to entertainers. Overtime will be given to entertainers after event or with their original payment.
- 6) Entertainers should contact us ASAP if there is an issue with travel or illness. Entertainer will forfeit pay if he or she doesn't show up to the event. Our company always contacts entertainers a week before the event to ensure they are ready. If an entertainer is late to an event, they must notify us and the client and either stay later or take a reduction in pay because of not being able to fulfil contracted time.
- 7) NO promotion or sale of MLM, other jobs, events, causes, or businesses is allowed without permission from our company.
- 8) DO not contact client for your own business anytime within 14 months after the original booking date.
- 9) Please refrain from any adult humor, profanity or non positive speech at any show.
- 10) Background clearances and Insurance certificates are needed prior to working first event.
